CHARLES KARUTH & CONRAD HEINSZEN

C KARUTH & COMPANY

The earliest records make reference in 1861 to J Karuth as residing in Manila, a ship chandler (retail dealer who specialises in supplies or equipment for ships). In 1862, Karuth & Company is noted, and shows that J Karuth is joined by H Heinszen, both working as merchants. The company name changes in 1863 to C Karuth & Company, with the following employees active between 1863 and 1867: Charles Karuth (merchant), Conrad Heniszen (merchant) and Luke Owens (clerk). It is interesting to note that although the first initials for Karuth (J) and Heinszen (H) listed in the 1861 and 1862 records differ to all later records (Charles and Conrad respectively), it is believed that these are one and the same.

In 1865, records show Charles Karuth and Conrad Heinszen as partners at C Karuth & Company. In 1867, they are also joined by Nicolaus Heinszen working as a clerk for the firm.

It appears that the partnership between Charles Karuth and Conrad Heinszen is further enhanced as evident from the change in the company name in 1868 to Karuth, Heinszen & Company. In the same year, Luke Owens departs the company and ventures out on his own, forming a merchant and ship chandlers business trading as L Owens & Company, located at Anloague 8, Manila. Owens moved back to England in 1876 at which time it appears that L Owens & Company ceased operations in Manila.

No further records have been found on Charles Karuth from 1869. It is assumed (although not substantiated) that he may have either retired or passed away during this period.

C HEINSZEN & COMPANY

Sometime between 1869 and 1872, the company undergoes a name change to C Heinszen & Company, with records in 1872 confirming this. From 1873 and to around 1888, C Heinszen & Company was located at Anloague 4, Manila. From 1873 Conrad Heinszen is absent from Manila, residing in Hamburg, but remained active with the business until it ceased operating after 1908. Nicolaus Heinszen also returned to Hamburg from 1879, also remaining active in the company up to 1902. There are no records indicating that either Conrad or Nicolaus Heinszen returned to Manila. The company continued to trade with various merchants running the firm during their absence. Sometime between 1883 and 1888 the company moved premises to Rosario 24, Manila, and again moved to Rosario 26 in 1889 where it remained until 1903.

C Heinszen and Company acted as agents for the following companies at various times between 1882 and 1908: Norddeutscher Lloyd; Hamburg-American Line of Steamers; Chinesische Kustenfahrt Gesellscharft; United States and China-Japan Line; East Indian Steamship Company; Rickmers R Rh and Schiffbau A G; Aachen and Munich Fire Insurance Company; Transatlantic Guter Verisch Ges; and East Asiatic Co Limited, Copenhagen.

In 1905, the company again moves premises, residing at Rosario 158, Manila. Conrad Heinszen Jr joins the company in 1906 and remained until the company ceased trading soon after 1908. No further records have been found from 1909, and it remains uncertain if the company simply ceased operations or was sold.




