INTRODUCTION

Philippine postage stamps with commercial overprints look similar to United States precanceled stamps, but unlike precanceled stamps they are required to go through the regular mail and be canceled. They were in use from 1924 to 1935.

Philippine businesses wishing to use commercially overprinted postage stamps were required to apply to the Philippine Bureau of Posts in Manila for permission to use postage stamps bearing an overprint by which their postage stamps could be identified in case of theft, or unauthorized use. The Bureau of Posts required full payment for the postage stamps at the time the order was placed and would then place the order with the Philippine Bureau of Printing. When the printing was completed, the Bureau of Posts would deliver the overprinted stamps to the customer.

It seems only five businesses in Manila took advantage of using postage stamps with commercial overprints. This may have been because the Bureau of Posts and Bureau of Printing were also located in Manila. Although, there were two different times when two businesses purchased postage stamps and applied their initials or, name on the postage stamps using a rubber handstamp until the Bureau of Posts provided them with overprinted postage stamps.

The records for the denomination of stamps purchased by each company and the quantities of each value overprinted have never been recorded in the philatelic press as the Manila Post office and all their records were destroyed during World War II.

By 1935 the H. E. Heacock company was the only Philippine business continuing to use postage stamps with commercial overprints. In October 1935 this company received an order from the Philippine Bureau of Posts prohibiting further use of the overprinted stamps, and demanded the return of all remaining stamps bearing the overprint; thus ending the use of commercial overprints.

Pricing:

Pricing the first catalog of the Philippine commercial overprints has been difficult as there is no adequate market data for these stamps.

At the time these stamps were in use it seems many collectors had very little interest in them, and did not collect them, or gather information about them. Some information did become available during World War II when Mr. Ramon Catala did some research at the Bureau of Posts, and provided Mr. Arnold Warren with a copy of his notes. Mr. Warren's copy of those notes are the only records of the commercial overprints that survived the war as the Manila post office was destroyed near the end of the war.

There is no record of the quantities printed of each denomination, and the information about when they were ordered, printed, and delivered is inconsistent.

The values for stamps provided in this catalog have been obtained from a number of sources, including auction prices realized, internet sales, and personal purchases.

Prices are for sound collectible stamps.

Mint stamps are normally more difficult to obtain, and should be valued accordingly. Although, sometimes the used stamp for some issues may be the more difficult to find.

A dash in the value columns indicates little information is known for establishing catalog prices.

No dash, or no price in the value column indicates none recorded.

Note: Only color varieties shown in the Scott Standard Postage Stamp Catalogue are included in this catalog.

The box below is provided to estimate the value
of pieces larger than a single stamp

Pairs, or strips; use the value of each stamp, Multiply by the number of stamps, and multiply by 1.25. Blocks of four; use the Value of each stamp, Multiply by 4, and multiply by 1.50. Blocks of six and larger; use the value of each stamp, multiply by the number of stamps, and multiply by 1.75.

On March 10, 1926, the sporting goods firm of A. L. Alkan, Inc. placed an order with the Philippines Bureau of Posts for stamps overprinted **A / MANILA / P. I.** in three lines of capital letters.

In 1931, this company was absorbed by the H. E. Heacock company and the stamps were withdrawn from circulation.

It is thought the Rambler Shoe Company initiated the use of a rubber handstamp in 1924 to identify their postage stamps. The handstamp had the letters **R. S.** enclosed within a single line box about the size of the postage stamp design. These handstamps continued in use until the Bureau of Posts delivered the overprinted stamps June 20, 1925.

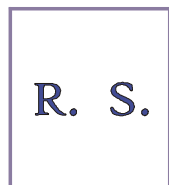

An order for postage stamps overprinted **MANILA / P. I.** in two lines of capital letters was placed with the Bureau of Posts May 27, 1925. They were delivered to the Rambler Shoe Company and its sister organization, the Howard Lux Company on June 20, 1925.

This overprint remained in use until 1929.

May 5, 1926, the department store H. E. Heacock Company placed an order with the Philippine Bureau of Posts for the overprint of **H / MANILA / P. I.** in three lines of capital letters.

These stamps were used until about 1929, when the current overprint stock was running low, and stamps with a new overprint were ordered.

The supply of **H / MANILA / P. I.** overprinted stamps was about depleted and the H. E. Heacock Co., in about 1929, received permission from the Philippine Bureau of Posts to use the overprint **HEACOCK'S / MANILA** in two lines of capital letters.

These overprints were also used by the C. L. Alcan Co. which merged with the H. E. Heacock Co. in 1931.

Early in 1935, some values of the "HEACOCK'S / MANILA" overprints were about depleted and the Philippine Bureau of Posts were not able to replace them timely. A rubber handstamp, similar to the overprint used by the Bureau of Posts, was acquired locally and applied to seven different values.

Note: Little is known about the history of this handstamp, and this catalog is merely reporting what has been pieced together from a number of different sources.

Few mint copies are known, and only the used 2c, and 20c have been recorded.

In 1935, the Philippine Bureau of Posts delivered the new 2c definitive issue overprinted "HEACOCK'S / MANILA" in two lines of capital letters. Some time later the Philippine Bureau of Posts also delivered the overprinted 20c of the new 1935 issue.

A few days after the 20c overprinted stamps were delivered to the H. E. Heacock Co., an order was received from the Philippine Bureau of Posts prohibiting further use of the overprinted stamps, and demanded the return of all stamps bearing the overprint. The unused remainder of the overprinted stamps were returned to the Philippine Bureau of Posts the same day.

In 1935, the H. E. Heacock Co. was the only commercial business continuing to use overprinted stamps for their internal control.

Brias Roxas, Inc. of Manila

Brias Roxas, Inc., a large mail-order business in Manila, requested overprinted stamps for their internal control. On May 26, 1926, the Philippine Bureau of Posts delivered the stamps which were overprinted **Manila / P. I.** in two lines of upper and lower case letters with a single 1.5 mm thick bar 4.2 mm above the "M" in Manila. These are the only Philippine commercially overprinted stamps in upper and lower case letters.

The "I" of P, "I." is 0.25mm higher than the "P."

Note:

Mr. Ramon Catala researched the records of the Philippine Bureau of Posts during WW II for information concerning the Commercial Overprinted stamps, and in 1942 shared that information with Mr. Arnold Warren. Mr. Catala was later executed by the Japanese, and the records of the Manila Post Office were destroyed in 1945 so Mr. Catala's notes could not be verified. Some collectors believe these stamps were printed privately, but Mr. Warren quotes Mr. Catala's information about the Type 7a Commercial Overprints. I have used the information provided by Mr. Warren.
